I LOVE working with early stage companies because of the energy, enthusiasm and creativity involved in all aspects of the work! There are no pigeonholes--no limits--we all do everything we can to convert ideas into successful businesses. My legal practice had focused for 20+ years on the intersection of sustainable energy and commodities law and regulation. Since many of the companies i worked with were start-ups or early stage, I naturally branched into working with other early stage companies, helping define their corporate, product and sales structure, as well as providing contracts and risk management policies and procedures.

Counseling start-up companies requires, in addition to a broad understanding of corporate, securities, labor and contract law, a solid grounding in conflict management and transformation. Disputes rarely arise over goals; but are frequent in developing strategies and tactics to achieve those goals. After my years spent running a litigation department, I had seen how unsatisfying and costly the litigation and arbitration system is for the participants, even those who prevail. I also saw many relationships destroyed by the process. The process was also wholly unsuited for many of the types of disputes that arise in a commercial setting, especially early stage companies.

In 2013, I co-founded the Center for Transforming Conflict in Washington, DC as a means to pre-empt unnecessary litigation and repair and strengthen relationships challenged by conflict in a commercial setting. Important relationships with Board members, partners, suppliers, customers and employees can be challenged by conflict. My work with clients facilitates resolution of the conflict while improving and strengthening the business relationship.
