



Why an ICO in Switzerland ?

ICO

ICOs are digital blockchain-based form of public fund-raising for entrepreneurial purposes.

Regulations

There is a lack of international regulations so far. Tough, if many want to preserve freedom, the market is more and more in demand to rely on rules. It is also legitimate to question how reliable are ICOs launched in today inclined countries, but where unreliable authorities could implement unilateral regulations, possibly retro-actively, eventually freezing the funds ?

Switzerland, "the most ICO-friendly country in the world" ?

Switzerland has stated "they wanted to be world leaders in cryptocurrencies"...

Also some banks now allow to have accounts in cryptocurrencies, which is great for corporations too.

The "helvetian" land is the first country to make "utility tokens" legal and protected by law.

Payment tokens and the asset tokens are also legal, but subject to financial rules and could be taxed.

Swiss Supervisory & assistance

The Swiss Financial Market Supervisory Authority (FINMA) has just published (February 2018) ICO guidelines and supports the federal government's Blockchain/ICO Working Group in which it is participating.

"However, I believe that it takes a good specialist to submit the token description to the FINMA, in order to have clearance from them. It is not an easy task", says Sean Kelly, recommending his clients to create a 100% owned LLC subsidiary in Switzerland, which then can sell tokens worldwide under Swiss law, and be protected. And still the money is in control of the company.

inherent ICO Risks

The FINMA has several times highlighted the risks that investors could encounter in ICOs since tokens acquired in such context can be subject to high price volatility. Considering that many "Initial Coin Offering" projects are at a pretty early stage of development, they are subject to various


